## 2 Introduction

### 2.1 Overview

The Older Americans Act Performance System (OAAPS) allows users to upload data using an approved .xlsx, .csv, .xml template. Upload samples and templates will be available for download in the approved .xlsx, .csv, and .xml format on the OAAPS site. The sample file will demonstrate how users can fill in the upload template by showing sample text and values. Once data has been uploaded, users will still have the option to manually update individual fields or re-upload the data file.

### 2.2 Purpose

This document will only cover sections that can be uploaded using the appropriate template. This document explains how to use the Title VII upload samples and templates to upload data into OAAPS for sections other than Cases and Complaints. Some sections in OAAPS are not uploadable and therefore data must be manually entered for those sections. This document only covers how to upload data into the sections that are uploadable.

**Important Note: The order of the column headers in the template and the data in columns A through D cannot be changed. Only the data in the value column can be changed.**
